  - (iv) Area or distance covered by CBMWTF: 150 Km. Radius
  - (v) Quantity of Biomedical waste handled, treated or disposed: 2000 Kg/day
- 4. This authorisation shall be in force for a period of 05 Years from the date of issue.

#### **Terms and Conditions of Authorisation**

- 1. The authorisation shall comply with the provisions of the Environment (Protection) Act, 1986 and the rules made there under.
- 2. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the prescribed authority.
- 3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the biomedical wastes without obtaining prior permission of the prescribed authority.
- 4. Any unauthorised change in personnel, equipment or working conditions as mentioned in the application by the person authorised shall constitute a breach of his authorisation.
- 5. It is the duty of the authorised person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.

### **Specific Conditions:**

- 1. This authorization is valid for Bio Medical Waste incineration-250 Kg/hour through 01 Nos. Incinerator, Auto claving- 500 Kg/batch and shredding-300 Kg/hour.
- 2. The CBWTF shall comply with provisions of the Environment (Protection) Act 1986 and the rules made there under.
- 3. The Authorization or its renewal shall be produced for inspection at the request of an officer, Authorized by the prescribed authority.
- 4. The Authorized person shall not rent, lend, transfer or otherwise transport the bio-Medical waste without obtaining prior permission of the prescribed authority.
- 5. It is duty of the Authorized person to take prior permission of the Board to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
- 6. CBWTF shall ensure that bio-medical waste shall be treated and disposed off in accordance with schedule-I and in compliance the standards prescribed in schedule-V of Bio-Medical Waste Management Rules 2016.
- 7. Bio- Medical waste shall be segregated into containers/ bags at the point of generation in accordance with schedule-I, prior to its storage, transportation, treatment and disposal. The Containers shall be labeled according to schedule-IV.
- 8. Bio-Medical waste shall not be mixed with Municipal or other wastes.
- 9. No untreated bio-medical waste shall be kept stored beyond a period of 48 hours. If it becomes necessary to store beyond 48 hours you must take permission of the prescribed authority and to ensure that it does not adversely affect human health and the environment.
- 10. CBWTF shall submit quarterly ambient air monitoring as well as stack monitoring report of incinerator done through Board's Laboratory on paid basis to ensure the prescribed norms
- 11. The CBWTF has to maintain the computer recording of online monitoring, automatic feeding system, temperature recording of primary and secondary chamber.
- 12. Colour Coded and lid covered containers must be used for segregation & collection of bio-medical waste.
- 13. CBWTF shall submit an annual report to the U.P. Pollution Control Board in from IV by 31st January every year. And include information about the categories and quantities of Bio Medical waste during the preceding year.
- 14. CBWTF shall maintain record related to the generation, collection, reception storage, Transportation, treatment and disposal and / or any form of handling of Bio Medical Waste in accordance with rule and guidelines, all records shall be subject to inspection and verification by the Board at any time.
- 15. It is within the power and functions of U.P. Pollution Control Board to modify/ revoke the terms and conditions of Authorization and issued under the Rule 10 of the Bio-Medical waste Management Rules, 2016.
- 16. CBWTF shall submit the details of attached Pvt. & Govt. Hospital/ Nursing homes /Clinic etc. alongwith the No. of Beds within 15 days time after the receipt of this authorization.
- 17. The occupier shall ensure compliance of Consent granted by Board under the provisions of Water (Prevention & Control of Pollution) Act, 1974 under section 25/26 and Air (Prevention & Control of Pollution) Act, 1981 under section 21/22 and also comply with the provisions of Hazardous & other waste (Management and Transboundary Movement) Rule 2016 and submit compliance report on quarterly basis. 18. CBWTF is directed to submit bank guarantee of Rs. 2.0 Lakh valid for 2 years for compliance of above
- 18. CBWTF is directed to submit bank guarantee of Rs. 2.0 Lakh valid for 2 years for compliance of above specific conditions within 15 days in the prescribed format on Rs. 100/- Non Judicial Stamp Paper.
